





Yet upon reporting to this unit, CLARK was unable to profit by the job opportunities given her in the Office of Personnel. Instead she has been confused in her actions, touchy in disposition and has failed to adjust to the work or her associates.
- 5. In the barracks, CLARK's adjustment was equally poor; she did not make friends or enter into group life. On several occasions she lost control of herself emotionally, cried and berated her treatment in the Spars. Her move to be privately quartered probably averted more serious trouble, since she was becoming a burden to others.

- 2. The following information is for your guidance and to aid you in ascertaining your status subsequent to discharge:

  - You are permitted to retain uniforms upon discharge and may wear same from place of discharge to your home within ninety (90) days after date of discharge. You are not permitted to wear uniform after arrival home, even though the ninety (90) day period has not expired. The uniform, if worn, shall be worn in such manner as not to discredit the service. Except for overcoat, shoes or raincoat, no outer or distinctive parts of uniform shall be worn with civilian clothing.
  - (c) You should register with the proper local board of Selective Service immediately subsequent to discharge.
  - (d) You are required to surrender all identification cards in your possession and you shall not hereafter use any identification card issued during service in the Coast Guard.
  - (e) Medical relief will be furnished by the U.S. Public Health Service in the event that application therefor is made within three (3) days subsequent to discharge.
  - (f) You will be afforded every assistance in seeking employment upon application to the U.S. Employment Service via nearest facility of the Veterans Administration.
